Hello Family,

Thank you for electing me to serve as our 2016 Treasurer

In the attached report you will see a detail description consisting of Mar 2016 Bank statement, and Monthly reports; detailing income and expenses. The Monthly Table is a rolling table capturing our 12 month donations and expenses with averages to verify our prudent reserve.

For Mar 2016, Area home groups have donated \$112. Our two expenses were \$50.00 rent to Nashville United Methodist Church, and Shay-Casper Co for printing mtg schedules for \$9.00, for a total of \$59.00. We have no outstanding checks currently. Our current ending balance is \$789.10, which is over our area prudent reserve is \$750.00. Therefore donation to Region is \$40.10 (wrote check for \$1 too much). Our three month average expense is \$99, and our yearly average expense of \$190; which is significantly less than our three month \$750.00 prudent reserve.
