

If you tell us orally, we may require that you also send us your complaint or question in writing within ten (10) business days. We will tell you the results of our investigation within ten (10) business days after we hear from you, and we will correct any error promptly. If we need more time, however, we may take up to forty-five (45) days to investigate your complaint or questions for ATM transactions made within the United States and up to ninety (90) days for new accounts, foreign initiated transactions and point-of-sale transactions. If we decide to do this, we will re-credit your account within ten (10) business days for the amount you think is in error, minus a maximum of \$50. Since resuming in-person RSC meetings, the region has used equipment borrowed from the Capital Area at the quarterly business meeting. We appreciate their generosity. We discussed purchasing our own equipment at several RSC meetings and an ad-hoc committee was formed to investigate. The research led them to propose options at various price points and ultimately recommend the mid-priced option B at \$1775. This hybrid equipment option allows the NC Region to continue to support all the area RCM's, subcommittees and trusted servants who are quite a distance away giving them the ability to attend without incurring cost and travel time.
