Tar Roanoke Area of NA Treasurers Report January 2017



Hello Family,

In the attached report you will see a detail description of December 2016 Bank statements, along with our monthly reports; detailing income and expenses. The monthly table is a rolling table capturing our 12 month donations and expenses with three month averages to verify our prudent reserve.

For December 2016, our beginning balance is \$675.13. Area home groups have donated \$72.77, and our total expenses, were \$107.00. Our available balance is \$640.90, which is below our prudent reserve, of \$750.00. If our prudent reserve was \$600.00, we would have donated \$40.90 to NC Region. We have 1 outstanding check for \$25.00. We had no Monthly bank service charge.

Our three month average expense is \$374.74, which is less than our three month \$750 prudent reserve (3 Months expenses).

For 2016, our monthly average Home Group contributions were \$144/Month and our Monthly average expense for the year is \$153 /Month, equating to a \$9 deficit/month, we dropped due to only two home groups donating. We had 6 months in the last 12 months were our expenses were less than, our home group contributions. Our highest 3 month expense in last 12 months was \$663.

18 months ago our treasurer could no longer support us, I stepped in to help our area as treasurer while holding two other positions, RCM and policy chair. I am grateful these did not conflict with each other. I feel that these are too much for me on a go forward term, therefore I will be stepping down from the treasurer and the policy chair to focus on being our regional service member (RCM). I will devote as much time as needed to assist my replacement

I truly want to thank all of you, (members of our special area), we may be small but we have lots of potential for growth. Once again thank for allowing me to serve as area treasurer.
