Hello Family,

In the attached report you will see a detail description consisting of May 2016 Bank statement, and Monthly reports; detailing income and expenses. The Monthly Table is a rolling table capturing our 12 month donations and expenses with averages to verify our prudent reserve.

For May 2016, Area home groups have donated \$283. Our expenses, for a total of \$281.00, giving us a balance of \$750. To meet our prudent reserve. We have one outstanding checks currently check # 312 for region donation of \$16.12. We had no Monthly bank service charge. Our current prudent reserve is \$750.00.

Our three month average expense is \$562, which is less than our three month \$750.00 prudent reserve (3 Months expenses). For the last 12 Months, our monthly average Home Group contributions were \$186/Month and our Monthly average expense for the year is \$206/Month, equating to a \$20 deficit/month. We had six months in the last 12 months were our expenses were greater than our home group contributions.
