### Open Forum

Reintroduction of Michael J.'s discussion from Committee Reports:

Michael M. – according to policy, page 9 3<sup>rd</sup> line – receipts required for travel expenses; John K – section 8 states federal guidelines for travel to be used; Dudley – section 6 states funds not used be returned; Dudley – why as an area that is financially struggling paying the federal rate for travel rather than gas receipts? Motion is being made.

Sabrina – Local Guide to Service: a section talks about Outreach; seek out Outreach Subcommittee Handbook; Michael M – repeated information from Local Guide to Service stated in policy was removed

Michael M requested prison visitation forms to be available online for others to visit in prisons

Owen – suggested ASC discusses homegroup needs and body will choose where Outreach should go during the following month

Chris C – suggested change in policy to be gas receipts rather than federal guidelines to enable possible budget increase for Outreach visits

Area email – Area has emails attached to account not being used as it was not published – do we keep them? What do we do with it?

MOTION 3: to reimburse RCM for travel \$186.94 which takes us under prudent reserve by \$49.99 – motion passed

MOTION 4: to have this Area provide a new group starter kit for new groups – take to homegroups for discussion as to dollar amount, number of pieces, and what the package will consist of – to help new meeting get started – motion moved to homegroups for discussion and suggestions

Discussion: starter packs available from world and another source for various amounts; do we

## Treasurers Report November 2016

Hello Family,

In the attached report you will see a detail description of October 2016 Bank statements, along with our monthly reports; detailing income and expenses. The monthly table is a rolling table capturing our 12 month donations and expenses with three month averages to verify our prudent reserve.

For October 2016, our beginning balance is \$708.87. Area home groups have donated \$113, and our total expenses, were \$105.80. Our available balance is \$716.07, which is below our prudent reserve, by \$33.93. The checks were written before area due to treasurer unable to make October meeting. We had no Monthly bank service charge.

Our three month average expense is \$482.83, which is less than our three month \$750 prudent reserve (3 Months expenses). For the last 12 months, our monthly average Home Group contributions were \$154/Month and our Monthly average expense for the year is \$157 /Month, equating to a \$3 deficit/month, we are getting better. We had 5 months in the last 12 months were our expenses were greater than, or equal to, our home group contributions.

This month there will be an increase in expense for RCM travel to Greensboro Region travel. Again-I revised the Monthly Balance report to make more visible treasure activities.

Next Month will be my last month as treasurer-if interested come to December Area or contact me for smooth transition and audit.
