If you tell us orally, we may require that you also send us your complaint or question in writing within ten (10) business days. We will tell you the results of our investigation within ten (10) business days after we hear from you, and we will correct any error promptly. If we need more time, however, we may take up to forty-five (45) days to investigate your complaint or questions for ATM transactions made within the United States and up to ninety (90) days for new accounts, foreign initiated transactions and point-of-sale transactions. If we decide to do this, we will re-credit your account within ten (10) business days for the amount you think is in error, minus a maximum of \$50. If we ask you to put your complaint in writing, and we do not receive it within ten (10) business days, we may not re-credit your account and you will not have use of the money during the time it takes us to complete our investigation.

RCM Report for Tar Roanoke ASC November 2021

Good afternoon Tar Roanoke Area!

I attended North Carolina Region of NA meeting via Zoom on October 23, 2021. Complete Minutes have not yet been distributed. I can forward to anyone requesting once I receive them. My notes along with some highlights from the draft of Regional Secretary's minutes are as follows:

Elections for Regional positions will start at our next meeting on January 22, 2022 – resumes for positions should be presented at that time. Per Policy - Elections are held every April in even years. Nominations are open at the October meeting and due at the close of New Business of the January meeting.

Insurance premium was renewed at \$3599. The policy has gone up \$675.00 due to new Area in our Region. Ad hoc committee to look into more affordable insurance.
